TOURNAMENT RULES:

1. You may bowl doubles more than once by changing partners or bowl with the same partner & cash once.
2. You must be a member of The Greater Des Moines USBC.
3. In the event of ties for a trophy, duplicate awards will be given.
4. USBC rules will govern this tournament. Rule 319 D does not apply.
5. Payout will be 1 in 4 entries. All prize money returned 100% in each division based on number of entries per division.
6. Failure to use proper average or make a correction prior to completion on the first game of a series shall disqualify score if submitted average is lower than actual average. Prize winnings based on submitted average if it is higher.
7. Handicap will be 100% of 220.
8. Last year's USBC highest book average for at least 21 games. If no book average is available, bowler will use an average of 185 for men & 165 for women, OR proof of current league average of 21 or more games as of date bowled will be accepted. All averages used must be USBC league averages (Rule 319a) Bowlers are responsible for verifying his/her own average.
9. The decision of the tournament committee shall be final unless an appeal is made using Rule 329.
