Discussion ensued about what Board Members heard from bowlers during the County Tournament.

There were some comments that the \$20 per Event fee was too high.

Another comment was if we were going to have a Ball Raffle.

A few questions about if we were going to have a banquet this year.

Manager Anderson suggested we make the Entry Fee \$10 per Event & \$3 for All Events next year. The Lineage would be paid by the Association. Director Van Blair suggested we state on the Entry Form that the Association is paying all Tournament Expenses & the Total Entry Fee is going to the Prize Fund.

President Tangeman suggested we hold 50/50 Raffles, Ball Raffles, Brackets, etc. during Leagues so some of the cost of covering the Lineage for the County Tournament can be recouped.

Director Van Blair stated he had not handed out any Scholarship applications yet. The junior bowlers have been busy on the recent weekends. Director Van Blair stated he would get the scholarship applications out within the next few weeks.

#### **New Business:**

Manager Anderson suggested the Association buy a copy of CDE's BTM-2013 Professional Tournament Software. This software package has a Bracket/Side Pot modules built in. Once the bowler information has been entered in the software, it can be brought directly in to brackets/side pots as needed.

Director Van Blair suggested we get it licensed so Mustang Lanes can use a copy of the software also.

Manager Anderson will check with CDE Software about the cost of obtaining 2 licensed copies of the BTM-2013 Professional Tournament software.

Director Van Blair suggested we hold a County 9-Pin Tournament to get bowlers to participate in a "fun" tournament. Discussion ensued about the format & when to hold the tournament. It was decided to make the format 4 Games of Qualifying (throw out low game) to a Step-Ladder finals. Cardinal Lanes could hold 1 on a Thursday evening, then Mustang Lanes could hold 1 on a Saturday afternoon. Dates & times to be firmed up at a later date.

Director Van Blair stated that Jason Mikkelson was interested in becoming a Board Member. Director Van Blair will invite Jason to attend the next Board Meeting

Date for the next board meeting was set to 1:00 Saturday, March 8<sup>th</sup> at Cardinal Lanes.

Director Van Blair made a motion to adjourn the meeting, seconded by Director Price, motion carried.

Meeting was adjourned at 1:50 PM.
