

Jasper County Bowling Association Directors Meeting

March 8, 2014 1:00 PM – 2:00 PM

With due notice having been given in accordance with the bylaws and a quorum being present, President Tangeman called the meeting to order at 12:58 PM.

Board Members Present:

Arlyn Vink, Barney Brown, Dave Rorabaugh, David Anderson, Dustin Kingery, Gary Price, Jeff Van Blair, Larry Anderson, Ron Jones, & Ron Tangeman.

President Tangeman read the minutes from the previous meeting. Director Vink made a motion to accept the minutes as read, seconded by Director Jones, motion carried.

Old Business:

Manager Anderson stated he had sent an email to CDE Software regarding purchasing 2 licenses of their BTM 2013 Professional Tournament software. According to the reply, we would have to purchase 2 copies at a cost of \$299 each. He also stated he sent CDE a reply to see if there was any way to get a discount since we are a USBC Local Association. He also sent an email to George Lambert (USBC Representative) to see if there were any discounts for USBC Local Associations purchasing CDE software.

Director Van Blair reported he has handed out several scholarship applications to the High School bowlers. He has not received any completed forms yet.

Discussion ensued on when to hold the County 9-Pin Tournaments & whether or not to open them to more than Local Association bowlers. There was a consensus to hold the tournaments in the late September to early October time frame & to open it up to any USBC sanctioned bowlers. There was also discussion on holding several 9-Pin tournaments during the season. We will have more discussions once the fall leagues are up & going next season.

New Business:

Director Jones made a motion to pay the Salary to Manager Anderson, seconded by Director Rorabaugh, motion carried unanimously.

Director Kingery made a motion we send Director Brown to the Jamboree, seconded by Director Van Blair, motion carried unanimously. Manager Anderson will check to see what paperwork needs to be filled out. Director Brown gave Manager Anderson Darrell Ernst's phone # (515-205-2891) as a contact with the State Association.

Director Rorabaugh made a motion to adjourn the meeting, seconded by Director Brown, motion carried unanimously.
