

IOWA WOMEN'S 700 BOWLING CLUB

23rd ANNUAL MAIL-IN TOURNAMENT

The Iowa Women's 700 Bowling Club conducts a mail-in tournament for all current members.

There are two forms which will be used. The entry form must be returned to the Iowa Women's 700 Bowling Club office postmarked no later than January 11, 2020. The score verification form must be postmarked no later than January 31, 2020. Certified league scores for the week of January 12 through January 18, 2020 will be used. If, however, your scheduled league bowling is postponed that week, scores bowled the week of January 19 through January 25, 2020 will be accepted.

This tournament will be handicapped at 100% of 220. Cash prizes will be paid on a ratio of 1 to 4 entries. A \$10.00 prize will be awarded to high scratch game and high scratch series each during this week.

Entry fee will be \$6.00 of which all goes to prize fund. The prize fund will be returned 100%.

TOURNAMENT RULES

1. This tournament will be conducted by the Iowa Women's 700 Bowling Club for its members. An entrant must be a current member of USBC. She must also be a PAID member of the Iowa Women's 700 Bowling Club or may join/renew upon entry in this tournament.
2. This tournament will be conducted by submitting **USBC CERTIFIED LEAGUE** scores bowled during a designated week in January. In the event that scheduled league bowling is postponed, scores bowled the following week will be accepted. **ONLY USBC CERTIFIED LEAGUE SCORES** will be accepted.
3. Entrants will use their highest previous season USBC CERTIFIED league average based on a minimum of 21 games. If the previous season average is less than 21 games, the highest current season USBC certified league average of 21 or more games as of January 1 will be used. All others will bowl scratch.
4. This tournament will be handicapped at 100% of 220.
5. USBC rule 319b will not apply. USBC rules 310a-3 will apply. Rule 319e is waived. Rule 319as, item #2 is waived.
6. An entry may be submitted for each USBC certified league in which the participant is bowling. Photocopies of the entry form and score verification form will be accepted. An entrant may, however, **CASH ONLY ONCE**.
7. The prize fund will be returned 100% and will be based on a 1 to 4 ratio.
8. This tournament will be USBC certified.
